1. The Lessee must be at least 18 years of age.
2. A rental day is 7:00 a.m. until 1:00 a.m.
3. Children must be supervised by an adult at all times. Running in any and all areas of the facility is not allowed.
4. Lessee will immediately report any electrical, plumbing, or mechanical problems that arise at the facility during the rental period to the GCFA Representative.
5. **If tables/benches are moved around in the pavilion.....they are to be RETURNED to original set up**

Trash:

The Fairground has 1 large trash dumpster. **ALL** trash must be placed in dumpster at the end of event.

Release and Indemnification Agreement:

In consideration of the use of GCFA facilities, Goliad, Texas, , Lessee agrees to defend, indemnify, and hold harmless the County of Goliad, the City of Goliad, Goliad County Fair Association, their officers, agents and employees from and against all liabilities, claims, and suits or demands for injuries to any person and / or damage to any property arising from the Lessee's use of the GCFA facilities.
